Discussion regarding Operating resulted in further amendments to move conference costs to account for the new Fire Prevention/Inspection Officer. Approximate 2015 surplus of \$45,000. though unaudited as yet. Operating Budget overall is same as 2015. Capital budget discussed. It was noted that reserve accounts need to be set up to reflect the 15 year capital plan. Member Nevills questioned the 2015 surplus amount questioned, whether it should be transferred into the Equipment Reserve account or should all or a portion be used to reduce the capital contributions by the municipalities, noting that prior to the 15 year plan, it mad sense to put surplus into the Equipment Reserve, but now there is a full replacement cost plan in place, it should be reconsidered. Also discussion regarding delaying vehicle replacement. Amount of MVA revenues applied against capital budget questioned. Chief McNeilly indicated the amount used is generally a 5 year average of MVA revenues. Secretary Treasurer will do an analysis and include appropriate amount in budget.
