Chief McNeilly reported on recent meeting with Fire Chiefs, Mayors and Chairs of Fire Boards. Currently waiting for repeaters, which come from Italy. Understood that County Emergency Management were going to fund, but now have been advised that they need to apply for County funding, and County will only fund 50%. Letter has been drafted signed by the Chairs of the Fire Boards, and to be presented by Chief Morden and Chief McNeilly to County Council, requesting full funding. Copy to be sent to municipalities for endorsement. Cost questioned. Chief McNeilly indicated total cost of \$106,000., being \$74,000 for microwaves, and \$32,000 for simulcast, needed by the eight municipalities in Dufferin for adequate communications. Resolution passed.
